 Baba College'.

 Publicity as 'Association for GES 2023' in our impact report and souvenirs which is mailed to a large network all over India

Deliverables from Langta Baba College:

- The college is expected to intensively publicize the event in its network and share relevant contact of the city with Entrepreneurship Cell, IIT Kharagpur.
- The College must ensure the participation (registration as well as payment) of at least 40 students in the summit.
- Provide E-Cell IIT Kharagpur with contacts so as to make GES 2023 a successful event.
- Mention of GES 2023 in <u>Langta Baba College</u> newsletter.

Other Incentives:

- Concession in the fees per individual if mass participation is ensured (INR 1300 per individual)
- Certification for attending the summit to each participant.
